



## CAMPUS CRIME DEFINITIONS:

*Excerpted from the implementing Regulations of the "Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act" (originally the Campus Security Act) originally published in the Federal Register on April 29, 1994 (Vol. 59, No. 82) and November 1, 1999 (Vol. 64, No. 210)*

1. Arson – any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle, college and personal property of another within the college main campus and its extensions.
2. Homicide
  - Manslaughter by Negligence – the killing another person through gross negligence.
  - Murder and Non-negligent Manslaughter – the willful (non-negligent) killing of one human being by another.
3. Robbery – the taking or attempting to take anything of value belonging to the college and/or from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear within the college main campus and its extensions.
4. Aggravated Assault – an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. (It is not necessary that injury result from an aggravated assault when a gun, knife, or other weapon is used which could and probably would result in serious personal injury if the crime were successfully completed.)
5. Burglary – the unlawful entry of a structure to commit a felony or a theft. For reporting purposes this definition includes: unlawful entry with intent to commit a larceny or felony; breaking and entering with intent to commit a larceny; classroom, office and house breaking; safecracking; motor vehicle and boat; and all attempts to commit any of the aforementioned to any college properties and/or personal properties within the college main campus and its extensions.
6. Weapon – The Weapon Law Violation of the Republic of Palau should be upheld in the college main campus and its extensions at all times including the violation of laws or ordinance dealing with weapon offenses, regulatory in nature, such as: manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; furnishing deadly weapons to employees, students and visitors; aliens possessing deadly weapons; and all attempts to commit any of the aforementioned in the college campus and its extensions.
7. Drug Abuse – The Drug Abuse Violation of the Republic of Palau relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs should be upheld in the college main campus and its extensions at all times. The relevant substances include: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (Demerol, methadone); and any identified dangerous non-narcotic drugs (barbiturates, Benzedrine).
8. Sex Offenses  
*(Sex offenses definitions straight from the National Incident-Based Reporting System Edition of the Uniform Crime Reporting Program)*

- A. Sex Offenses-Forcible – any sexual act directed against another person, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent.
- Forcible Rape – the carnal knowledge of a person, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent because of his/her temporary or permanent mental or physical incapacity (or because of his/her youth).
  - Forcible Sodomy – oral or anal sexual intercourse with another person, forcibly and/or against that person’s will; or not forcible against the persons will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.
  - Sexual Assault With An Object – the use of an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.
  - Forcible Fondling – the touching of the private body parts of another person for the purpose of sexual gratification, forcibly and/or against that person’s will; or, not forcibly or against the person’s will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental incapacity.
- B. Sex Offenses – Nonforcible – unlawful, nonforcible sexual intercourse.
- Incest – nonforcible sexual intercourse between persons who are related to each other within the degree wherein marriage is prohibited by law.
  - Statutory Rape – nonforcible sexual intercourse with a person who is under the statutory age of consent.
9. Hate Crimes – crimes involving bodily injury to any person in which the victim is intentionally selected because of the actual or perceived race, gender, religion, sexual orientation, ethnicity, or disability of the victim.
10. Smoking – smoking and/or lighting of cigarette is prohibited within the college main campus and its extensions including college properties such as: vehicles and boats; college sponsored activities away from the main campus and its extensions.
11. Alcohol Use/Abuse – the use, possession or distribution of alcohol is prohibited within the college main campus and its extension including college properties such as: vehicles and boats; college sponsored activities away from the main campus and its extensions. (The use of alcohol while not on college campus and time, if any employee/student reports to campus with the presence of the item in his/her bodily systems or if an employee’s/student’s work performance is affected by the use of the item.)
