The following are changes/corrections that had been approved by CPC for 2012 - 2016 General Catalog.

1. **Architectural Drafting (AD):** *(page 78 under Course Descriptions)*
AD120 Title, description and credit changes:

Course title and description as it will appear in the catalog:

Introduction to Architectural Drafting – this course introduces the student to manual drafting using a tee square and/or drafting machine. The topics covered in this course include freehand sketching as a problem solving and communication tool, introduction to the basic drafting, and elementary design principles. At the completion of this course, the student will have drafting skills necessary to complete a basic set of drawings for a simple house. Pre: None (2 credits lec., 1 credit lab)

2. **Computer Science (CS):** *(page 88 under Course Descriptions)*
CS100 course description change:

Course description as it will appear in the catalog:

This course covers basic information processing and uses of a computer including basic application software. Topics include basic computer concepts, navigating in a Windows Operating System and computer software including word processing, spreadsheet, data base and PowerPoint presentations. Pre: None. (3 credits lec.)

3. **Construction Technology (CT)** *(page 89 under Course Descriptions)*
Credit modification:

CT212 – after description and prerequisite notation, the credit notation should now read 3 credits lec). There is no longer a need for any lab.

4. **Information Technology (IT):** *(Page 97 under Course Descriptions)*
Credit correction:

IT110 – after description and prerequisite notation, the credit notation should read **3 credits lec.** There is no lab for this course.

5. **Library and Information Services (LS):** (page 99 under Course Description)

Credit correction:

LS 115 - after description and prerequisite notation, the credit notation should read **3 credits lec.**

LS120 - after description and prerequisite notation, the credit notation should read **3 credits lec.**

LS125 - after description and prerequisite notation, the credit notation should read **3 credits lec.**

Course Deletions:

The following courses need to be deleted from the LS program: LS210 and LS214

LS –AAS degree students have a choice to take LS210 or LS 215. LS210 has not been offered in recent semesters as students choose to take LS215. Deleting LS210 will not affect the LS-AAS program in a negative way.

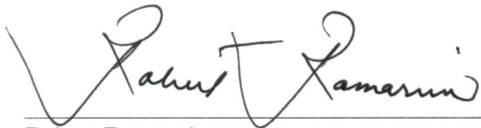
LS-AS degree students may take either LS214 or IT215 as it is cross-listed with LS214. LS214 has not been offered in recent semester as students choose to take IT215. Deleting LS214 from the LS-AS degree program will not affect the program in a negative way.
