I. Academic Degree Program Purpose (Program Description) and Relationship to the College Mission

1. State the purpose of this academic degree program below.

As stated in the 2016-2020 Palau Community College General Catalog, "This [Liberal Arts] program is designed for students who wish to complete the first two years of general college work prior to transferring to a four-year college or university or for students desiring two years of general education beyond high school" (p.64).

Liberal Arts offers a variety of courses for students who may either be preparing for a specific major or who may need a general array of courses to later determine a specific major. Consequently, seeing as many local students may opt for Palau Community College prior to furthering their respective education abroad; the Liberal Arts program provides a good option for students in easily allowing them to transfer their earned credits to other accredited institutions. The students will learn specific skills in writing, reading, oral presentations, and research. The students will also develop critical thinking and analytical skills, in addition to analyzing and researching the learning material, as well as critical thinking/writing skills which shall be developed through various essay writing/research assignments and oral presentations. The program competencies for critical thinking, information technologies, oral communication, written communication, and individual/community represent the minimum outcomes expected of students who have completed their general education. As stated on page 64 of the 2016-2020 Palau Community College General Catalog, students who complete the LA program will be able to:

- 1. Demonstrate proficiency in critical thinking and problem-solving skills.
- 2. Demonstrate proficiency in the areas of listening, reading, and oral/written communication
- 3. Demonstrate proficiency in the areas of computer literacy and information competency/technology.
- 4. Develop a fundamental understanding of the Humanities including the significance and chronology of major events and movements of Western civilization.
- 5. Develop a fundamental understanding of the Natural Sciences, including major concepts, principles, and theories of the biological and physical environment.
- 6. Develop a fundamental understanding of the Social Sciences, including major concepts of social, political, geographic, and economic structures.

2. How is the academic degree program supporting the overall mission of the College?

PCC Mission Statement:

"Palau Community College is an accessible public educational institution helping to meet the technical, academic, cultural, social, and economic needs of students and communities by promoting learning opportunities and developing personal excellence" (2016-2020 Palau Community College, p. 12).

The LA program aligns with and continues to support the mission of the College.

The Liberal Arts program continues to support the overall mission of the College through the offering of its required courses to meet the various needs of the students; therefore, providing students with a well-rounded and represented degree for either contributing to the community and/or enrolling into a four year college and/or university.

3. Provide a brief history of this academic degree program below. Include the updates of major changes and accomplishments since the last review.

The precursor to the Liberal Arts program was the Associate in Arts degree program that first appeared in the 1983 catalog requiring 100 quarter credit hours for completion. Thereafter, in 1985, the total credits required were 66 credits with a core emphasis on English, Quantitative, Natural Sciences, Humanities, and Social Sciences in addition to the completion of 21 credits of electives. From 1990 to 1998, 3 credits of Applied Studies (Trades & Industries or Occupations Divisions courses) were added toward the program requirements, thereby reducing the required electives to 18 credits. The next significant change to the program occurred in 1998 when 6 credits of Communications and 6 credits of Computer Technology were added while reducing the required electives to 9 credits and dropping 3 credits of Applied Studies. By 2004, 9 credits of Communications in addition to 3 credits of Health and Physical Education were required while yet again reducing the required electives to only 3 credits. Up until summer 2008, 66 credits hours were required for completion of the program. Beginning of fall 2008 until present, 65 credits are now required with core emphasis in the areas of English, Quantitative, Natural Sciences, Humanities, Social Science, Communications, Computer Technology and Health and Physical Education.

Over the years, the program consistently graduates students. To date, the program has graduated a total of **83** students (*Refer to Chart 3.1*). Of the 83 graduates, **31** are males and **52** are females (*Refer to Charts 3.2 and 3.3*). Of the 83 graduates, **80** are from Palau, **2** are from the USA and **1** is from Yap (*Refer to Charts 3.4 and 3.5*).




Chart 3.1. LA program graduates from summer 2009 to spring 2019. To date, the program has graduated a total of 83 students.





Chart 3.2. Of the 83 program graduates from summer 2009 to spring 2019, 31 are males and 52 are females.






Chart 3.4 Of the 83 program graduates from summer 2009 to spring 2019, 31 are males and 52 are females.




Chart 3.5 Of the 83 program graduates from summer 2009 to spring 2019, 80 are from Palau, 2 are from the USA and 1 is from Yap.

Over the period of this three year cycle, from fall 2015 to summer 2018 the program has graduated a total of **13** students (*Refer to Chart 3.6*). Of these **13** graduates, **6** are males and **7** are females (*Refer to Charts 3.7 and 3.8*). Finally, **12** of these **13** graduates are from Palau and **1** is from Yap (*Refer to Charts 3.9 and 3.10*).




Chart 3.6. From fall 2015 to summer 2018, LA program has graduated a total of 13 students.




Chart 3.7 Of the 13 program graduates from fall 2015 to summer 2018, 6 are males and 7 are females.




Chart 3.8 Of the 13 program graduates from fall 2015 to summer 2018, 6 are males and 7 are females.




Chart 3.9 Of the 13 program graduates from fall 2015 to summer 2018, 12 are from Palau, and 1 is from Yap.




Chart 3.10 Of the 13 program graduates from fall 2015 to summer 2018, 12 are from Palau, and 1 is from Yap.



Table 1a, 1b and 1c show the number, type of classes that were enrolled by LA students, and total semester enrollment from Fall 2015 to Fall 2017, Spring 2016 to Spring 2018 and Summer 2016 to Summer 2018. The enrollment figure is a duplicate number because same LA student are counted more than once based on their enrollment in the courses required for the program. The tables also indicate number of students who passed, failed, and withdrew from the courses.

Based on the data provided in Table 1a, an average number of 255 students were enrolled in the required program courses from Fall 2015 to Fall 2017. Additionally, 79% of the enrolled students passed, 12% failed, and 9% withdrew from the courses. Overall, the data indicates that majority of the students enrolled in the courses required for the LA Program successfully completed the required courses.

Based on the data provided in Table 1b, an average number of 260 students were enrolled in the required program courses from Spring 2016 to Spring 2018. Additionally, 76% of the enrolled students passed, 13% failed, and 11% withdrew from the courses. Overall, the data indicates that majority of the students enrolled in the courses required for the LA Program successfully completed the required courses.

Based on the data provided in Table 1c, an average number of 44 students were enrolled in the required program courses from Summer 2016 to Summer 2018. Additionally, 91% of the enrolled students passed, 5% failed, and 4% withdrew from the courses. Overall, the data indicates that majority of the students enrolled in the courses required for the LA Program successfully completed the required courses.




Figure 2 including its trends analysis.


