CRRSAA Report and Disclosure and CRRSAA Assurance
As of March 30, 2021
Quarterly Fund Report

 A. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the intuition has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

The Palau Community College (PCC) acknowledges that it signed and returned to the U.S. Department of Education the Certification and Agreement on April 30, 2020, and gives the assurance that PCC intends to use no less than 50% of the funds received under section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students. The total amount of CARES ACT funds allocated to PCC was \$759,490.

- B. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

 The Palau Community College (PCC) acknowledges that on March 04, 2021 the institution received a student supplemental award of \$379,745 under CFDA 84.425E, Coronavirus Response and Relief Supplemental Appropriations Act 2021 and gives assurance that it will distribute the entire \$379, 745 to provide Emergency Financial Aid Grants to Students.
- 2. A. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grant to Students.

The total amount of funds, PCC, as a part of the CARES Act, received on May 21, 2020 from U.S. Department for Emergency Financial Aid Grant to Students is \$379,745. In addition, a total of \$13,481 from the HEERF Institutional Portion was used to cover a tuition portion of 20 students taking correspondence courses during Fall semester 2020.

B. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

The Palau Community College (PCC) acknowledges that on March 04, 2021 the institution received a student supplemental award of \$379,745 under CFDA 84.425E, Coronavirus Response and Relief Supplemental Appropriations Act 2021 and gives assurance that it will distribute the entire \$379, 745 to provide Emergency Financial Aid Grants to Students.

 The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).

As of January 09, 2021, a total of \$393,226.00 of Emergency Financial Aid Grants has been distributed to students under section 18004(a)(1) of the CARES Act. Therefore Palau Community College has distributed its entire Emergency Financial Aid Grants to students under section 18004(a)(1) of the CARES ACT.

4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the Cares Act

The estimated total number of students (duplicated) at PCC who are eligible to participate in programs under section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grant under section 18004(a)(1) of the Cares Act is **1026**.

5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the Cares Act.

As of January 09, 2021 the total number of students (duplicated) who received an Emergency Financial Aid Grant under section 18004(a)(1) of the CARES Act is **1026**.

6.The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the Cares Act

PCC used the following methods to determine **which** students will be eligible to receive the Emergency Financial Aid Grants and **how** much they would receive under Section 18004(a)(1) of the Cares.

Based on guidance from the US Department of Education, PCC determined that all students who are eligible for Title IV aid and not enrolled in a fully online degree programs are eligible to receive a

CARES Financial Aid Grants. Eligibility criteria to receive Title IV funds include but are not limited to the following:

- Be enrolled in a degree or certificate in an eligible program;
- Be a U.S. citizen or an eligible noncitizen;
- Have a valid Social Security number;
- Be registered for Selective Service (if male);
- Have a high school diploma, or its equivalent (such as GED/HiSET);
- Not in default on a federal student loan;
- Not owe money on a federal student grant;
- Be maintaining Satisfactory Academic Progress
- a. Distribution of the CARES ACT grant funds to students was based on the available funding and the number of eligible students enrolled in Spring 2020 and Summer 2020. In addition, the distribution of funds was also based on eligible students' enrollment status (the number of credit hours such as Full-time 12 credits or more; ¾ time 9-11 credits; ½ time 6-8 credits; less than ½ time- 1-5 credits). The total amount distributed for Spring semester 2020 was \$179,513 and Summer semester 2020 was \$83,400. Distribution of the CARES ACT grant funds to students enrolled in Fall Semester 2020 was distributed equally based on the available funding of \$116,832 and the number of eligible students. In addition, \$13,481.00 from the HEERF Institution Portion was used to directly pay for a tuition portion of 20 students taking correspondence courses.
- b. Eligible students received CARES Act financial aid grants ranging from \$263 to \$2435 depending on their enrollment status (credit hours) and enrollment in correspondence courses.
- c. Checks that were not picked up by the students after **14 days** were mailed to students at the address listed on their student record.

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Students were informed that these funds were to be used for those additional costs of attendance which are related to the disruption of campus operations due to COVID-19 such as food, housing, course materials, technology, health care, and child care.

PCC students were notified of the availability of CARES Act concerning Emergency Financial Aid Grants through the institutional primary website, college Facebook page and campus bulletin boards.

Eligible students were informed to pick up their CARES checks at the Business Office, Student Account section. Checks that were not picked up after fourteen (14) days were mailed to students at the address listed on their student record.

Financial aid applicants and recipients were reminded that they have the opportunity to receive a financial aid adjustment due to the recent unemployment of a family member or independent student, or other circumstances described in section 479A of the HEA (20 U.S. Code § 1087tt).
