#### **Purpose:**

Program review at Palau Community College is a process that provides an extensive evaluation of academic and non-academic programs on a three-year basis. The results of yearly assessments (using the FAMED process) are compiled into the one three-year review cycle.

The purpose of program review is to evaluate program sufficiency to allow definite strategies to be developed for major revisions, to provide information for consideration when decisions are made, and to develop recommendations to improve institutional effectiveness.

In doing the assessment/evaluation the following were the data sources: latest mapping of CLOs, PLOs and ILOs. Upon review of the data sources there are some missing data, and data that are inconsistent and are not tallying. Thus, there is a need to clean and validate the data.

To ensure consistency and validity of the evaluation, it used the BU major's data base and extract information on BU and BA courses from the same database to avoid inconsistency.

# I. Academic Degree Program Purpose (Program Description) and Relationship to the College Mission

## Summary of the academic program purpose

A school and its academic programs' relevance link closely on the needs of the society, and how its citizen could fill in that needs to advance socio-economic development. People drive socio-economic prosperity. Thus, it is imperative that its citizens are knowledgeable, and they have the right attitude and skills to fill in the job market requirements.

Palau Community College recognizes the need to prepare its students for a job market in a constant state of change. On April of 2004, a community survey was conducted to determine the need for the Business Administration program. The questionnaire was administered to various public and private sectors; the questions and responses were overwhelmingly in favor of such a program. On September 15, 2005, Business Administration program was officially a program at the college. We endeavor to offer contemporary subject matter, including computer courses, information technology, and to encourage the student to view education as a lifelong process.

The objectives of the business administration program enable the students to fill in the job market in the business field. Graduates of the program are qualified for entry-level positions, such as accounting clerk, auditor's assistant, sales and office manager, and administrative assistant. The program also leads to a Bachelor of Arts or Bachelor of Science degrees. Cognizant of its important role in the community, the program also provides a platform for a continuing learning among those working in the business industry.

Upon graduating with an Associate Science degree in Business—Business Administration, the graduate will be able to:

- 1.Effectively communicate business concepts orally and in writing to organizational stakeholders.
- 2. Understand the ethical perspectives, and an ethical and legal framework for decision-making.
- 3. Acquire business knowledge and develop skills to analyze and solve complex managerial problems through active learning and experiential education.
- 4. Use information technologies to access, analyze and report business information.
- 5. Develop an awareness and understanding of the cultural, legal, economic and geo-political forces that impact business operations in a global economy.
- 6. Understand, analyze and use the accounting/financial information generated by organizations for their stakeholders, and will understand financial theories, analyses and markets.
- 7. Understand the economic forces that impact organizations operating in the global business environment, and will use economic analyses to make business decisions.


The following are some chronological events with regard the history of the academic degree:


Since the last review in the summer of 2018, it has maintained the course learning outcome and the program learning outcome within and above the proficiency level of 70%. Also, there are no major changes.

BA courses BA220 -Marketing, BA159 -Macro, TH219 HRM, BA213 -Business Finance, BA214 Business Law was change from BA code to BU under Business Administration program.

# II. Program Data

Provide summary of Figure 1 including its trends analysis.

From 2018 to 2021, there were a total of 218 students enrolled in any of the courses offered under the BU degree. Enrolled is defined as those students who stayed on until the end of the semester; and either passed or failed. Not included in the analysis are the students who enrolled and eventually withdrew because it does not have a bearing in the class load.

There is a slight increase in enrollment between school years 2018-2019 (n=70) to 2019-2020 (n=78) by 11.4%. An 10.25% decreased is noted in School Year 2020-2021 at 70. The impact of COVID 19 pandemic to the enrollment of students is not significant in 2020-2021.

Figure 2 shows that there is a decreasing trend of enrollment during Fall Semester from 2018-2020. On the other hand, Spring Semester enrollment showed a 28.5% increased from 2019-2020; and had a slight decreased of 7% from 2020-2021. This reflects the period of the COVID 19 pandemic. This means that the pandemic has not significantly impact on the number of enrollments under the BU degree program.

Almost 100% of students passed except for Fall 2018 and Spring 2019 and 2021 where each had one failed student, which is insignificant.

#### Program students course completion Fall (2018, 2019 and 2020):

Table 1a shows the total number of enrolled BU students during Fall semester 2018 (n=29), 2019 (n=26) and 2020 (n=23). There is a slight decrease of enrolled students in the Fall 2019 by10.3% and the following year Fall 2020 at 11.5%. The shift from in-person to online in Fa 2020 (during COVID-19 pandemic) might have resulted to the decrease. Percent of students (96.5%) who passed in Fa 2018 increased to 100% in Fa 2019 and remained at 100% in Fa 2020.

After of last program review, the course code numbers for BA110 and BA214 have been replaced into BU110 and BU214, respectively in Fa 2020 thus these courses are assessed collectively.

#### Program students course completion Spring (2019, 2020 and 2021):


Table 1b shows the total number of enrolled BU students during Spring semester 2019 (n=35), 2020 (n=44) and 2021 (n=41). There is an increase of enrolled students in Spring 2020 by 25.7% and a decrease in Spring 2021 at 6.8%. The shift from in-person to online in Sp 2021 (during COVID-19 pandemic) might have resulted to the decrease. Percent of students (97.1%) who passed in Sp 2019 increased to 100% in Sp 2020 and decreased to 97.5% in SP 2021.


After of last program review, the course codes with BA and TH have been replaced with BU in Sp 2021 thus these courses are assessed collectively.

#### Program students course completion Summer (2019, 2020 and 2021):

Table 1c shows the total number of enrolled BU students during Summer 2019 (n=6), 2020 (n=8) and 2021 (n=6). There is an increase of enrolled students in Summer 2020 by 33.3% and a decrease in Summer 2021 at 25%. 100% of the enrolled students pass the course in Su 2019, Su 2020 and Su 2021.

Overall, there are a total of 385 students enrolled in BU courses, including students from BA and TH tracks. Figure 3 shows an increasing trend in terms of the number of students from SY 2018-2019 to SY 2020-2021. Significant increase is seen from SY 2019-2020 to SY 2020-2021 from 119 to 149, respectively. This constitutes a 25% increase.

Figure 4 represents the number of students enrolled per semester from 2018-2021. Comparing Fall enrollees, the graph reflects a slight increase from Fa 2019 to Fa 2020. An upward trend is also reflected for Spring 2019 to 2020 and 2020 and 2021 by 14.7% and 20.5%, respectively. Despite COVID 19 pandemic, we saw an increase in enrollment during Spring. In this graph, there is an observed plateau of enrollees during summer from 2019-2021.

#### All students course completion of program course Fall (2018, 2019, 2020):


Table 2a shows the total number of enrolled students during Fall semester 2018 (n=43), 2019 (n=35) and 2020 (n=49). There is an increase of enrolled students in Fall 2020 by 40%. Noted in Fal 2019 is the high number of students who withdrew (n=7). Almost all students passed except one who failed in Fall 2018 that failed.

#### All students course completion of program course Spring (2019, 2020, 2021):

Table 2b reflects an increase trend in enrollment during Spring 2019 (n=68), 2020 (n-78) and 2021 (n=94). Almost all students passed except one student who failed in Spring 2021.

#### All students course completion of program course Summer (2019, 2020, 2021):


Students enrolled in this summer course are all graduating students. The data show a plateau of the number of enrolled students from 2019-2021.

In total, there are 233 unique students enrolled in BU degree program at all levels. About 23 students graduated with BU degree from 2018 – 2020. The number of graduates in the Summer of 2019, 2020 and 2021 remains at 6, 8, and 6, respectively. In Fa 19, Sp 20 and Sp 21, BU program have produced solo graduates.

Overall, 23 students earned their AS Degree. This number of graduates is quite significant. That there are several graduates proved the quality of student selection, teaching curriculum, retention strategies, including an interesting course program, a supportive peer environment and a course curriculum that is responsive to the students' needs. These interventions have greatly helped the students' transition leading to a bachelor's degree and hopefully find a job.

Figure 6 shows a constant number of faculty teaching the course. Mostly, the challenge faced by the teacher is in adjusting the teaching methods to help the students understand, acquire the right attitude, and apply the correct skills. To find the right balance in teaching contents to encourage learning of students at different levels and phases of learning.

Through time the assigned teacher for the program course has developed a better way of applying and adjusting the course program outline. Having a solo teacher ensures consistency of lecture styles and ability to integrate concepts in the different courses. The number of full-time instructors teaching BU courses increase by 200% in 2020.

#### **Summary of Course Assessment:**

Figure 7 shows the course learning outcomes (CLO) average percentages by course and by year. Overall year averages have improved from 87.86% in Year 1 to 90.33% in Year 2 and 90.6% in Year 3.

Courses BU110, BU120, and BU223 have consistent 100% score on the course learning outcomes in the three-year review.

BU158 learning outcome average have steadily improved from Year 1 to Year 3 (81.06% in Y1, 86.09% in Y2 and 88.77% in Y3).

BU159 CLO average increased in Y2 (88%) from 74.28% in Y1 and decreased to 78.57% in Y3. BU213 learning outcome average have steadily improved from Year 1 to Year 3 (80.45% in Y1, 81.61% in Y2 and 89.47% in Y3).

BU214 CLO decreased in Y2 (83.55%) from 87.83% in Y1 and recovered to 88.33% in Y3.

CLO averages of BU219 have steadily improved in the three-year review (87.6% in Y1; 90.48% in Y2; 95.24% in Y3). CLO average of BU220 increased in Y2 (88.35%) from 82.96% in Y1 and decreased to 78.09% in Y3.

Steady increase averages are seen in BU158, BU213, and BU219. Though the averages of BU159 and BU220 have declined in Y3 compared to Y2, these Y3 averages improve from Y1. Also, the Y3 average of BU214 have improved from Y1 after its decline in Y2.

# Action Plans for improvement of course and program learning outcome, student learning and student achievement:

- 1. The signature assignments proved an effective approach for in-depth understanding on the principles and applications of the course. This should be continued and further enhanced. Additionally, there is a need to review the CLO on a regular basis. Like having variations in the type of test, measurement or rubrics that is tailor fitted to the students. This will generate interest among the students to actively participate.
- 2. Simplifying the course and adopting supplemental projects and reports were observed to increase class participation and retention. There is a need to continue this method, but also conduct an internal evaluation to see the impact of this approach.
- 3. Incorporating attendance of students in overall assessment encourages students the attend classes. It is compelling to retain this strategy to keep students on track.
- 4. Further strengthen the teaching-and-learning strategies to continue adopting a problem-based approach to learning, and exploring blended modalities like workshop, mentoring, and self-learning Continue the strategy on participatory class problem solving exercises ensure group learning and support. Thus, it is necessary to adopt this methodology.
- 5. It will be helpful to run a quick focus group discussion to determine the reasons of withdrawing from the course and must be documented to guide in developing interventions to improve screening and retention of students.
